Conditions of Entry

- Entering this competition constitutes acknowledgement that PCAV rules apply and acceptance of these rules
- All competitors to **register** on arrival.
- PCAV club member cards must be inspected at the secretary's office. If a current pony club card cannot be presented, an additional fee of \$10.00 applies. Please ensure details are correct before the event.
- Competitor numbers – the organizing committee will pre-allocate and advise numbers. Competitors **may** supply their own numbers: bridle, saddlecloth or back (preferable). Body numbers will be available at the event.
- **Before riding**, Open riders must have completed Day attendance form and fee. Please submit and pay with entry.
- All riders must present to **gear check** before competing in each phase.
- **All riders** to wear **medical armbands and approved helmets** AS/NZ 3838, EN1384, ASTM F1163, PAS015. Spot checks may occur.
- The organizing committee reserves the right to cancel any class or competition; divide any class; alter any times; refuse any entry with or without stating the reason.
- Competitors may ride two horses subject to the conditions of PCAV *Handbook of By-laws* multiple horse rules.
- No refunds after closing date except with vet or medical certificate. An administration fee of \$10 will apply.
- Pony club riders to wear full pony club uniform. Open riders to wear suitable riding clothes i.e. jacket, jumper or shirt and vest.
- Horses must be at least 4 years old, no stallions, colts or rigs.
- Riders under 8 years are ineligible.
- No dogs allowed, not in vehicles, not on leads, not at all! Without exception.
- PCAV Lunging Policy applies.
- Queries, protests, horse abuse, rules are per PCAV *Handbook of By-Laws*.
- PCAV Alcohol Policy applies.
- Neither the organizing committee of this event, Wangaratta Pony Club Inc or the PCAV accept any responsibility whatsoever for any accident, damage, injury or illness to riders, spectators, animals or any other person or goods.
